- ✚ The Mayor met with Chief Witherspoon concerning the expectations of the City and the Policing from Pioneer Village PD.


### PUBLIC BUSINESS


- ✚ There is a new trucking business that will be moving next to (on the left of) US Trucking on Old Preston Hwy N.
