

ORDINANCE NO. 2007-05

AN ORDINANCE PROHIBITING CERTAIN MOTOR VEHICLES UPON STREETS WHICH ARE MAINTAINED BY THE CITY OF HEBRON ESTATES, EXCEPTIONS.

WHEREAS, the use of a city street by vehicles which exceed the weight and size limits the street was constructed to carry results in damage to the street and creates a hazardous condition for other users of the city street; and,

WHEREAS, unnecessary damage to city streets results in an expense to city government which is not equitable to have paid by all city residents; and,

WHEREAS, the City Council of the City of Hebron Estates wishes to maintain safe streets at the lowest possible cost to city taxpayers, now; therefore,

THE CITY COUNCIL OF THE CITY OF HEBRON ESTATES, BULLITT COUNTY, KENTUCKY DOES HEREBY ORDAIN AS FOLLOWS:

SECTION I: It shall be unlawful to operate the following defined vehicles on any street which is maintained by the City in the City of Hebron Estates:

1. "Truck Tractor" means any motor-propelled vehicle designed to draw and to support the front end of a semitrailer. The semitrailer and the truck tractor shall be considered to be one (1) unit, when used in conjunction with a semitrailer.
2. "Semitrailer" means any vehicle designed for carrying persons or property and being drawn by a motor vehicle and is so constructed that some part of its weight and some part of its load rests upon or is carried by another vehicle, except that:
 - (a) "Semitrailer" shall not include any vehicle designed for carrying persons or property and being drawn by a motor vehicle registered according to the provisions of KRS 186.050(4)(a) and used by a farmer only for transporting persons, food, provender, feed, machinery, livestock, material and supplies necessary for his farming operation, and the products grown on his farm.

Except, for the purpose of making delivery and/or picking up a load within the municipal boundaries of the City, or performing maintenance in which case such vehicle may be driven on such street for not more than the minimum distance necessary.

SECTION II: Any person who violates the provisions of this Ordinance or any posted weight limitations shall, upon conviction, be fined not less than Fifty Dollars (\$50.00) or more than Five Hundred Dollars (\$500.00).


SECTION THREE: This Ordinance shall be published according to law.

SECTION FOUR: Any ordinance or part of an ordinance in conflict with this Ordinance or any part of this Ordinance are repealed.

SECTION FIVE: Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

Given second reading, voted upon and passed at the regular meeting of the City Council of the City of Hebron Estates, Bullitt County, Kentucky, the 4th day of September, 2007.
